



***St. Louis Corvette Club Meeting  
October 6, 2009 - Sunset Lakes Banquet Center***

The meeting was called to order at 7:04pm by president Theresa Luebcke. The Pledge of Allegiance was recited and everyone was welcomed. Theresa introduced the current board members, all committee chairpersons and immediate past president Ron Hagenow. Members were reminded to sign the attendance sheet and purchase 50/50 tickets. A sign-up sheet was also made available for monthly birthday cakes for next year's meetings.

**Guests/ New Members**

Several guests were welcomed. Sandy Zahradka who has a black 2009 GT1, Johanna Brown who is member Ann Brown's daughter, and Larry and Elise Akins who have a LeMans blue 2004 coupe. We also welcomed new member Jim Stockwell who has a silver 1996 collector's edition convertible.

**Treasurer's Report**

Sara Gibson reported a balance of \$2486.97 as of August 31<sup>st</sup>. Income of \$81.00 (50/50 monies) and \$60.00 (VA fund), disbursements of \$65.91 (Dierbergs/Fain), \$13.86 (50/50 tickets) and \$26.22 (newsletter) leaving a balance as of September 30<sup>th</sup> of \$2521.98. There were no additions, corrections or discussion by the membership.

**Secretary's Minutes**

There were no additions, corrections or discussion to the minutes for the September 1<sup>st</sup> meeting as published in the newsletter.

**Membership Report**

Ruth Howard reported current membership of 87 regular members and 12 associate members for a total of 99 members. Ruth recognized members celebrating September birthdays and anniversaries. Ruth read an e-mail that was sent by June Fain to the club thanking them for their prayers, support and attendance at Jerry's funeral. Theresa reminded members 2010 dues are payable prior to the election of officers at the November meeting. Dues must be paid prior to voting at the November meeting. They are \$75 for a couple's membership, \$45 for individual and \$25 for associate members.

Les Gibson made a motion to allow surviving spouses or significant others of deceased members to remain members of the club, even if the car has to be sold. Rich Luebcke seconded the motion. Steve Lyle said in other clubs in which he participates, the surviving spouse becomes an honorary member for life and does not pay dues, even if they no longer have a Corvette. Theresa Luebcke proposed the motion be the club make June Fain an honorary member. She will not have to pay dues or own a Corvette. Ron Hagenow said he will be responsible for getting it into the by-laws. The motion was passed by the membership to make June Fain an honorary member of the club for life with no dues.

**National Corvette Museum Ambassador's Report**

Judy Dooley gave the report. She attended the ambassadors' meeting at the museum over the Labor Day weekend. There was discussion about an addition being made to the museum on the other side of the highway. It will be an autocross and high speed track. If anyone is interested in following the progress of the addition, there is a special link on the museum website.

The 1,500,000<sup>th</sup> car produced at the plant has been purchased by the museum and will be on permanent display there.

Judy has tickets for a 2010 torch red coupe that will be raffled at the museum on January 28<sup>th</sup> at 2pm. The tickets are \$10 each and make great “stocking stuffers” for Christmas.

Rich Luebcke mentioned the Corvair exhibit going on now at the museum.

### **National Council of Corvette Clubs Governors Report**

Rich Luebcke gave the report. The NCCC Governors’ meeting was held in St .Louis on September 12<sup>th</sup>. The Midwest Region Governors’ meeting was held in the morning. The Midwest Region has 2860 members and consists of clubs from Illinois, Minnesota, Wisconsin, the Route 66 club and our club. The Midwest Region has the largest number of future Corvette owners. Paul Haack, the regional competition director, spoke about safety at autocrosses. Apparently, a competitor at one of the autocrosses this year lost control and “took out” a light pole, and the timing and judging trailer along with other things.

The 2009 NCCC Convention held in Colorado Springs did turn a profit, which is good as not all of them turn a profit.

The 2010 NCCC Convention will be in West Palm Beach.

Windy City Corvette Club has put in a bid to hold the 2011 NCCC Convention in Tinley Park, Illinois. Should they be accepted, Rich is going to ask that the St. Louis Corvette Club sponsor an event in conjunction with Route 66 Corvette Club and Great Rivers Corvette Club. Rich thinks we could get some visibility and make a name for ourselves. A decision about the bid will be made in November.

The NCCC is creating a youth member category for youths age 16 to 21 or 25 if in college to get more young people into the organization.

The NCCC will be raffling a 2010 Grand Sport at next year’s convention.

Route 66 Corvette Club is hosting an Octobercross event this weekend at the GM plant with four events and Saturday and three on Sunday. Rich has details if anyone is interested.

Peggy Craig said she spoke with the NCCC governor of Route 66 Corvette Club at an event last weekend. The Route 66 club would like to have three of our seven sanctions for next year so they can offer a longer weekend of autocrossing in August.

The next governor’s meeting will be in November.

### **Website Update**

There was no website update.

### **Sponsor Report**

Ken Barron gave the report. Ken approached someone he knows at ELCO Chevrolet and they have agreed to sponsor our club. Ken thanked Ruth and Randy Howard who made up a top notch proposal and were very instrumental in the process of obtaining the sponsorship. ELCO plans to have a technician or a salesman at our next meeting. Club members will have a contact person at ELCO and they are working out the details on discounts. ELCO has paid the club the sponsorship fee of \$2500 for 2010. Theresa wants to get some of our sponsorship committee to meet with the guy Ken has been working with at ELCO to find out what they expect from our club and what we will be able to do for them in return.

Randy Howard reported that Skip Weber from Weber Chevrolet did call him several times after ELCO became our sponsor. He was sorry he did not respond quickly enough. Randy said they are in the wings in case anything happens with ELCO and we may do some “nonclub” events for them to keep them in the door.

Jeff Craig said he has sent a few members to ELCO for service work. One of his former bosses, John Brinkman is one of the service advisors at ELCO. Jeff advised members if they need service work to talk to John Brinkman or Randy Ferguson at ELCO and mention Jeff’s name. Club members just need to show their paid membership card to get discounts at ELCO. Members will get their paid membership cards at the next meeting. If anyone needs their card before the meeting, call Ruth Howard and she will mail it to you.

**Dessert**


Thanks to Kevin and Jamie Smull for providing this month's cake. Ken and Judy Barron have volunteered to provide a cake for next month's meeting.


